# 3. HAZARD IDENTIFICATION

Limited evidence of a carcinogenic effect.

Toxic: Danger of very serious irreversible effects through inhalation, in contact with skin and if swallowed.

Solvent will have a defatting action on the skin making it more susceptible to dermatitis and sensitisation. Inhalation of vapours may cause headaches or dizziness.

# 6. ACCIDENTAL RELEASE MEASURES

Ensure adequate ventilation. Wear protective clothing and suitable respiratory protection. # **11. TOXICOLOGICAL INFORMATION**

#### Inhalation

Toxic by inhalation. This product contains a volatile solvent, methylene chloride, which is a Category 3 Carcinogen, which means there is no evidence of carcinogenicity in humans and limited evidence in animal inhalation studies. Exposure to significant vapour concentrations or injestion of large quantities can take some time to eliminate from the body. Large concentrations can be fatal due to CNS effects.

#### Skin

Toxic in contact with skin. Solvent may remove essential oils from the skin making it susceptible to attack from other chemicals.
